ITEM

The Mayodan Town Council met at 6:00pm on June 8, 2020, at 101 N 10th Ave, and with a quorum present Mayor Cardwell called the meeting to order.

PUBLIC HEARINGS:

A. Town Manager Lessa Hopper reported that Hampton’s Taxi, owned by Annette and Michael Lilly, applied for the taxi franchise for 2020-2021. They have operated the taxi service and been awarded the franchise for many years. She stated that all paperwork was in order and there have been no complaints lodged regarding the taxi service.

Mayor Bud Cardwell opened the public hearing to hear public comment regarding the 2020-2021 Taxi Franchise at 6:04 p.m.

No questions or comments from the public.

Mayor Cardwell declared the public hearing closed at 6:05 p.m.

Motion: by Councilman Allred, seconded by Councilman Wall to approve the 2020-2021 Taxi Franchise for Hampton’s Taxi Service.

Ayes: Councilmen Wall, Allred, Cardwell, and Councilwoman Barnes.

Nays: None.

Motion carried unanimously.

B. Mayor Bud Cardwell opened the public hearing to hear public comment on 2020-2021 proposed budget at 6:06 p.m.

Manager Melessa Hopper expresses the budget has been submitted for review and consideration, all funds within the budget are balanced and all revenues and expenditures are identified. Total budget is \$5,608,043. The budget is based on a tax rate of .63 cents per \$100 of valuation, with no increase in the rate over last year and does not include a water/sewer rate increase or increase in fees at this time.

Mayor Cardwell declared the public hearing closed at 6:15 p.m.

Motion: by Councilman Cardwell, seconded by Councilwoman Barnes to approve the Budget Ordinance 2020-2021.

Ayes: Council members Allred, Cardwell, Holland, Wall and Barnes

Nays: None.

Motion carried unanimously.

Motion: by Councilman Wall, seconded by Councilman Allred to approve \$0.63 per \$100 valuation tax rate for the 2020-2021 budget.

Ayes: Council members Allred, Barnes, Cardwell, Holland, and Wall.

Nays: None.

Motion carried unanimously.

OLD BUSINESS:

A. Update on Parking Lot Retention Wall

Councilman Wall stated that the Town should go with the original plan of having poured concrete for the retaining wall. He stated he feels this would be stronger and better for long term.

Motion: by Councilman Wall, seconded by Councilman Allred to construct with poured concrete and rebar for the retaining wall.

Ayes: Councilmen Wall, Allred, Cardwell, and Councilwoman Barnes.

Nays: None.

Motion carried unanimously.

B. Sewer Replacement- North 3rd Ave

Public Works Director Joey Hudy informed Council that the estimate for replacing the sewer line on N. 3rd Avenue at the creek crossings would be approximately \$18,000. The cost for the entire project is \$23,000.00. The recommendation from staff is to replace the line and set the new manhole for \$23,000.00.

Motion: by Councilman Cardwell to only replace sewer lines in creek in the amount of \$18,000.00.

Motion failed due to the lack of a second.

Motion: by Councilman Allred, seconded by Councilman Wall, to replace sewer lines for the entire project in the amount of \$23,000.00.

Ayes: Councilmen Wall, Allred and Councilwoman Barnes.

Nays: Councilman Cardwell

Motion carried.

C. Update on Chemical Tank Replacement

Mike Sears gave an update to council that the construction at the water treatment plant was near completion and that they expect to be finished by the end of the month with the project.
