Resolution Adopting the North Carolina Records and Retention Schedule Effective April 11, 2022

WHEREAS, "public record" means any document, paper, letter, map book, photograph, film, sound recording, magnetic or other tape, electronic data processing record, artifact, or other documentary material, despite physical form or characteristics, made or received pursuant to law or ordinance in connection with the transaction of public business by any agency of North Carolina government or its subdivisions; and

WHEREAS, without a retention program public records can accumulate, causing the need for additional storage space; and

WHEREAS, without a schedule for disposal, valuable documents can be mistakenly discarded; and

WHEREAS, the Municipal Records Retention and Disposition Schedule is endorsed b the Division of Archives and History and the Department of Cultural Resources; and

WHEREAS, the Town of Mayodan currently uses this system for record retention and disposal;

NOW, THEREFORE, BE IT RESOLOVED that the Mayodan Town Council hereby adopts the North Carolina Records and Retention Schedule, as updated by the N.C. Department of Cultural Resources in accordance with N. C. General Statues, effective April 11, 2022 a copy of which is on file in the Town Clerk's Office.

TOWN OF MAYODAN AMENDMENT TO MAYODAN TOWN CODE OF ORDINANCES CHAPTER 8, BUSINESS AND BUSINESS REGULATIONS ARTICLE III, BEER, AND WINE SALES- SEC. 8-56 HOURS REGULATED

WHEREAS, the Town Council of the Town of Mayodan finds it necessary and desirable to amend the Mayodan Code of Ordinances, CHAPTER 8, BUSINESS AND BUSINESS REGULATIONS, ARTICLE III, BEER, AND WINE SALES- SEC. 8-56 HOURS REGULATED, previously adopted by the Town of Mayodan.

NOW, THEREFORE BE IT HEREBY ORDAINED by the Town Council of the Town of Mayodan, State of North Carolina that said ordinance be amended as follows:

"ARTICLE III

CHAPTER 8, BUSINESS AND BUSINESS REGULATIONS

ARTICLE III, BEER, AND WINE SALES

Sec. 8-56. Hours regulated.

(a) In accordance with G.S. 18-107(3), no malt beverages (beer) or wine shall be sold between the hours of 2:00 a.m. Sunday and 12:00 p.m. (noon) Sunday.

(b) Any person or firm found in violation of this section shall, upon conviction, be guilty of a misdemeanor and shall be fined not more than \$50.00 and/or imprisoned for not more than 30 days.

PROCLAMATION PROCLAIMING "A DAY OF PRAYER FOR UKRAINE" APRIL 12th, 2022

WHEREAS, Ukraine has been a sovereign and independent state since August 24, 1991, upon its withdrawal from the Soviet Union and since enjoyed the freedom of an independent state; and

WHEREAS, on February 24th, 2022, Russia, under the leadership of its President, Vladimir Putin launched an unprovoked invasion on Ukraine, not only targeting their military, but innocent citizens, children and hospitals; and

WHEREAS, the citizens of the Town of Mayodan have been shocked and appalled by the unprovoked and unjustified attack on Ukraine and condemn these acts of aggression; and

WHEREAS, as a people of faith we stand together in unity with the people of Ukraine as they fight to protect their homeland and democracy; and

WHEREAS, this day of prayer for Ukraine is a prayer for the protection of their democracy and for the security of their citizens as they flee this aggression; and,

WHEREAS, Town of Mayodan stands in solidarity and comes together in prayer for the people of Ukraine seeking peace for their country and strength and healing in this uncertain time.

NOW, THEREFORE, the Town Council of Mayodan proclaim April 12th, 2022 a Day of Prayer for the Ukrainian people and call upon citizens of all faiths and backgrounds to come together in prayer at 12:00 noon on said date.
